DIRECTOR'S MESSAGE

Let me welcome you to what is, for Region 3, the start of a new year, and the start of my two year term as Director. I am looking forward to the next two years with both excitement and apprehension excitement that I will have a chance to make a difference with the goals I (and the ExCom) pursue, and apprehension because David Conner will be a "tough act to follow" at both the Region and Board levels.

I got a taste of the Board meetings during November, when incoming Directors sit in on the meetings and caucuses, and several "orientation" sessions. In five very full days, I attended the USAB meeting, the RAB Caucus, the Board of Directors Caucus, the RAB meeting, the Board of Directors meeting, the RAB Directors' forum, the Industry luncheon, several RAB committee meetings, and orientation sessions on RAB, the IEEE, parliamentary procedure, and the laptop computers used at the Board meetings.

Having attended RAB meetings when I was RAB Awards and Recogni-

tion Chairman in 1988-89, I am very impressed by the "paperless" meetings now held by the BoD, and the semipaperless meetings held by RAB. The endless rustling of paper and snapping of 3-ring notebooks all but disappeared, and with ROOT, reference material was literally at our fingertips. Reports are electronically submitted and electronically disseminated - saving hours of work by the staff, and an untold number of trees. The first task of the incoming ExCom will be to fill out their committees. If you have an interest in working on a committee, or on specific projects, please let me or the appropriate chairman know; as in a job interview, don't say you'll work on "anything" - that leaves me to guess where your strengths are and where your interests lie. You will find that I am very "project oriented", with emphasis on end results that will make life easier for lots of people. I have some projects in mind, the ExCom chairmen have others. I am looking for other project ideas that can be pursued by ExCom committees, and projects that would be pursued by sections. Partial funding is available for projects where the results can be used by other sections.

The next meeting will be held in Louisville, KY, February 5-6, 1994. Joe Cole, Area 8 Chairman, has been very effectively implementing an "Area 8 Committee" in recent years, where members from the Area 8 sections have agreed to serve as "Area 8 representatives" to the Region committees. I am planning to move the ExCom meetings around the region, and started with Area 8 because I couldn't remember the last time we had been there. I am interested in getting proposals from other places we have not been recently - I will need a local contact

to do hotel visits, etc. - please let me know if you are interested in "hosting" the region ExCom.

Finally, I hope you are making plans now for your section to be represented at the Annual Region 3 Committee meeting Sunday, April 10, in Miami. The general consensus last year was that it was hard for people to be out from work on Monday, so in 1994 we will be having the Region meetings on Saturday and Sunday. Saturday from 1-5pm will be used for the PACE Workshop and other committee meetings, including an E-mail session and a Leadership Development Workshop. Saturday evening, the PACE

TREASURER'S REPORT

Greetings. Region 3's finances are in good shape. Expenses are generally within budget and several income items have exceeded original projections. This additional income plus the controlled Sections Congress expenses eliminated the need to tap the reserves as was originally planned when the budget was adopted. The reserves will actually grow by about \$30,000 in 1993. The expenses and income against the '93 Budget was presented at the December ExCom along with a tentative budget for 1994. Please submit any input you have for the 1994 Region 3 Budget to your Area/Council Chair as soon as possible. The Region 3 1994 Budget will be formally adopted in February 1994. The Area/Council Chairs have more detail if desired.

I have attached a copy of a draft of the 1994 Region 3 Budget. This budget is a variation of the one presented at the December '93 ExCom meeting and attempts to reflect the decisions made at that meeting. The actual '94 Budget will be proposed by the 1994 Finance Committee and approved by the '94 ExCom at the February meeting. The attached budget shows a deficit of \$49,167 reflecting several additional costs in 1994: automation efforts, e-mail connectivity charges, increased committee expenses for new activities in some committees (Membership Development and Conferences), Operation and Awards Manual reprinting, increase seed money to SoutheastCon '95 and an increase in

student travel due to the location of the SoutheastCon '94. The planned budget will leave the region with an estimated reserve of 80% of 94's expense budget at the end of 1994 conservatively within IEEE guidelines. I wish to thank Debbie Powers and Dan Jackson for serving on the Region 3 Finance Committee. They both helped out quite a bit. I want to especially thank Debbie for overseeing the Sections Congress process. I wish good luck to Roy Harris who taking over as Region 3 Treasurer for 1994. He brings a lot of experience to the position and I am sure the Region's funds will be in good hands.

Region 3 travel policy remains unchanged from the last newsletter. The mileage reimbursement for approved car travel is \$0.28/mile. Be sure to seek approval from the Region Director prior to the travel. Section chairs should be planning their travel to the Region 3 meeting in Miami and watching the "air fare" wars for a good price. Submit reimbursement vouchers for travel to the Director who will forward it to Roy Harris for reimbursement.

PAST DIRECTOR'S REPORT

During my two year tenure as Past Director, I plan to use this column to discuss a wide variety of topics. Here are my first two topics.

US Tax Exempt Status

IEEE recently received reclassification as a 501c(3) organization within the US. As such, its federal tax status changed to "tax exempt". One of our US-based Region 3 leaders (namely Jim Howard) inquired about the availability of a taxexempt status at the state level.

At my request, Richard Schwartz, IEEE Staff Executive for Business Administration, reviewed the status of the 13 states represented (in whole or in part) in Region 3. Dick found that all but one state fell into one of two categories. The first category of states had no provision for a tax-exempt status for our type of organization. The second category allowed our type of organization to attain a tax-exempt status but required, in return, that taxes be collected on all products provided within the state. The net result would be that the benefits gained from the tax-exempt status would be "swamped" by the tax collection process ... costing IEEE members more money in the long

The "bottom line" is that the only state associated with Region 3 where attainment of a tax-exempt status is feasible is the State of Arkansas. Therefore, tax-exempt status is being pursued by IEEE for the State of Arkansas. So, the only winner in Region 3 will be the Memphis Section ... and only if they "cross the border into Arkansas" to make their purchases and do their business.

"Friends of IEEE"

Traditionally, IEEE has divided its workers into two classifications: staff and volunteers (i.e., non-paid IEEE members). Unfortunately, this classification scheme ignores a most important group of IEEE supporters: our office associates (secretaries who handle many of our clerical functions and peers who "fill in" for us when we are away from the office on IEEE business) and our spouses (who "put up" with our professional involvement and often handle accounting, clerical, and gofer chores on our behalf). IEEE is beginning to realize that these non-IEEE member contributions are significant and deserve recognition. These non-IEEE contributors are being called "Friends of IEEE".

My challenge to you is to seek out and recognize the "Friends of IEEE" that support your work in IEEE and the work of your Section. For example, the Alabama Section, after SoutheastCon '92, made a special effort to let each of the "Friends of IEEE" that worked in SoutheastCon '92 know how much the Section appreciated their efforts on be-

half of IEEE. In my case, in addition to my wife, I have had three great "Friends of IEEE", associates: Charlotte Oliver, Lou Ann Faulkner (who worked with me until last July), and Maria Sparks (Lou Ann's replacement). These ladies have contributed an inordinate amount of time to IEEE activities. Without their assistance, I would never have been able to fulfill my IEEE duties.

This public acknowledgment is one way in which I am recognizing them. During this past December, I also gave each one of them a memento to recognize their service to IEEE and to thank them for their contributions. Who are your "Friends of IEEE"? What are you doing to recognize them?

The Florida Council has been VERY active over the past year. Some of the Council accomplishments for the 1993 calendar year include:

- Reactivation of the Gainesville Section
- Funding of Travel to Section's Congress

- Five(5) Council Meetings
- All Sections current with head quarters

REACTIVATION OF GAINESVILLE SECTION - Several newsletters were created and mailed to all IEEE Gainesville Section Members. Each newsletter sought volunteers to help "Get the Section back up and running". They have elected officers and held their required five meetings for 1993.

The Florida Council will be filing the Gainesville Financial report for 1993 and then turning over all remaining funds to the Section. In addition, we will monitor and assist the Section to make sure they are receiving all the support they require to make the Section successful.

FUNDING OF TRAVEL TO SECTIONS CONGRESS - The Council chose to hold a FC meeting in San Juan during the Sections Congress. In order to encourage more participation from the Florida Sections, the FC offered assistance with funding for travel in the amount of \$200.00 for each Section represented at Section's Congress. IT WORKED! TEN of the twelve Florida Sections were represented at the Congress.

All the Sections attending the Sections Congress felt it was an extremely successful event. Everyone came away with a much better understanding of what IEEE is and what it has to offer. We plan to continue helping the Florida Sections attend each and every Sections Congress.

DISTRIBUTION OF FUNDS FROM SOUTHCON TO SECTIONS - Motions were passed pertaining to the funds the FC receives from its 25% ownership of the SOUTHCON show.

REPRESENTATION OF IEEE AT STATE SCIENCE FAIR - For the second year in a row, the FC represented the Florida Sections at the Florida State Science Fair. The FC began judging and presenting awards at the State Science Fair for both the Junior and Seniors about two years ago. Most Sections are involved with their local county Science Fairs.

FIVE FC MEETINGS HELD - By utilizing both the Sections Congress and SoutheastCon, the FC was able to hold five(5) meetings and still come in under budget for travel. Plans call for continuing to hold an FC meeting at each SoutheastCon and to hold between three and five meetings per year.

ALL SECTIONS CURRENT - One



AREA 6 (AL,MS,LA)

As my term as Area 6 Chairman comes to a close, let me say that I have thoroughly enjoyed working with the Region 3 Executive Committee (EXCOM) over the past two years. Under the leadership of outgoing Region 3 Director Dave Conner, the Region has flourished ... both from an economic standpoint and an organizational standpoint. The membership of Region 3 has been well represented on the Board of Directors by the strong voice of Dave Conner. The new Area 6 Chairman for 1994-1995 will be Dale Caston. Dale is an active member of the New Orleans Section and has served on the Region 3 EXCOM as Awards Chairman for 1992-

In a recent letter circulated to the Area 6 sections within Louisiana and Mississippi by Donald A. Preston (PACE

Chair of the New Orleans Section and former Area 6 Chairman), he proposed that the Region 3 sections within Louisiana and Mississippi transfer from Region 3 to Region 5. Various advantages for such a move were cited in the letter. The Region 3 sections currently within Louisiana and Mississippi are the New Orleans Section, the Baton Rouge Section, the Mississippi Section and the Northeast Mississippi Subsection. The first step in the procedure for accomplishing a section transfer is a majority vote by the Section Executive Committee, in a regularly scheduled meeting, to propose to Section Members that a transfer take place. The Executive Committee of the Mississippi Section (including officers of the Northeast Mississippi Subsection) met to discuss the proposed transfer on September 21, 1993. Both advantages and disadvantages of the proposed transfer were discussed in detail. The Mississippi Section EXCOM voted unanimously to remain within Region 3. The EXCOM's of the New Orleans and Baton Rouge Sections have voted to consider the proposed transfer further. Currently, they are conducting a straw vote by phone and mail to determine if enough members are interested in the transfer.

At the latest Region 3 EXCOM meeting in December, the outgoing EXCOM members passed a motion by a narrow margin to consider buying laptop computers for all EXCOM members. The approximate cost of this purchase would be \$40,000. Yes, you read that right ... FORTY THOUSAND DOLLARS of Region 3 money would be spent so that the Region could conduct so-called "paperless" meetings. I, for one, am vehemently opposed to such a frivolous use of Region 3 money ... YOUR MONEY! The benefits of this purchase would in no way justify such an expense. Forty-thousand dollars would go a long way for other Region 3 needs such as increasing section rebates, enhancing the existing employment assistance programs for the ever growing number of unemployed IEEE members within the Region or increased financial support for student branches to participate in Southeastcon. I am sure that Region 3 could introduce many other proposals which would yield tangible benefits to the Region membership in general, rather than unjustifiable

benefits to a few. If you disagree with this \$40,000 expense, you should tell the incoming members of the EXCOM. ABOUT THE CONFERENCE: The theme for Southeastcon '94 is "Creative Technology Transfer - A Global Affair". The logo represents the dawn of new partnerships between industry, education, society and new eras: Expanding the education and training methods of our schools, industries, and society through the imaginative use of interactive multimedia technology; facilitating the imagination of new technologies, research, and design in a global society; and accelerating interactive techniques of efficient information transfer and access across our modern world of science and society. Miami, in many ways, represents this modern world with its lush, green, year-round scenic beauty, clean air and water, multi-universities and schools that offer broad educational choices, and a multi-cultural society that represents our global community of the world. As our imagination of new technologies and multimedia enhancements continues to aid our invention of new and exciting products, many remain caught up in a world where much of our education and training are based on methods similar to those dating back to the "invention of chalk and board". This is changing; coming soon are wide applications of interactive multimedia, and coming later are wireless-networked electronic notebooks, access to vast data bases, cellular microwave, interactive optical video at home, virtual reality, and more! Southeastcon '94 will bring together science and engineering professionals from global corners, to interface and continue dialogues of new ideas and multimedia innovations; and will enhance the atmosphere of partnership research and learning between industry, schools, and society.

GENERAL INFORMATION: Southeastcon is the yearly IEEE Region 3 Technical Conference for the purpose of bringing regional Electrical Engineering professionals and students together and sharing information, particularly through the presentation of technical papers and presentation of student accomplishments. The Student Activities Committee has developed a number of initiatives that, when implemented, should benefit our students. The Branch Mentor program has been established and a brochure describing the duties of this position is available from IEEE Headquarters. Please encourage your section to take this opportunity seriously by appointing mentors for your branches and notifying me of such appointments. Establishment of the Outstanding Student Design Award, which is a local Student Branch level award consisting of a certificate prepared by IEEE Headquarters, was recently approved. A trial Branch Leadership Workshop to be conducted in Region 3 includes two components: (a) training a selected group of "trainers" at SoutheastCon '94 and (b) dividing the region into four geographical areas and conducting a training session in each area during Fall 1994. It is hoped that this workshop will become a standard for all other IEEE regions.

Other items under review within IEEE include establishing an Outstanding Student Branch Award, sponsoring an International Student Paper Contest and including Potentials in the recent graduates package for two years after graduation. Also, RAB is considering the production of a Resource Officer Orientation Training (ROOT) module for Student Branches.

Florida International University (FIU) will host the 1994 Student Conference in Miami in April. The FIU students are working diligently to ensure the success of the conference. For example, a videotape "Miami Movie" will be distributed to all Student Branches as an adver-

tising medium. A number of exciting activities have been planned and we would appreciate your support for and participation in the Student Conference.

EMPLOYMENT ASSISTANCE

USAB Employment Assistance Committee (EAC) Activity. At the USAB EAC meeting on October 9, 1993 at Chicago, IL, several items of interest to our members who are seeking employment assistance were discussed and committee action taken.

Job Bank USA

Job Bank USA, which is a software driven employment assistance service which would match member resume qualifications and employer needs, made a proposal to IEEE to becomes an Associate Partner. The Committee had previously reviewed and commented on the proposal. EAC Chairman John Martin, MAC Chairman Bill Middleton, and USAB MAC Staff Bill Anderson reported on their meeting with Job Bank USA. Following the report the Committee voted to proceed with the negotiations. At the November meeting of the United States Activities Board, the EAC was urged to proceed promptly to implement the agreement with Job Bank USA. Subject to IEEE approval, publicity about this service will be forthcoming shortly.

Job Listing Service Via IEEE E-Mail

As reported in the Fall 1993 issue of the IEEE Region 3 Newsletter, a proposal to offer an IEEE Job Listing Service which had been previously approved by the Committee was reported on at this meeting. Chairman Martin reported that very little progress had been made on establishing the IEEE Job Listing Service. The lack of progress was largely due to the shortage of staff time available to develop the software to establish the Service. Dick Riddle volunteered to proceed with preparing job listing information for the Job Listing Service with the intent that it be turned over to the Staff in the future for operation. This item was discussed at the November meeting of the USA Board. Concern was expressed about the cost of both staff and computer time that would be required. The EAC was urged to proceed promptly but to try to make the Service self-supporting. Your Region 3 member of the EAC strongly supports the Job Listing Service and believes that it is much needed by our IEEE members, particularly in view of continued down sizing of major U.S. cooperations which employ our members.

SPECIAL REVIEW COMMITTEE

ATTENTION - PAST & PRESENT COMMITTEE CHAIRS - The IEEE Policy and Procedure 9.13 calls for a periodic review of all the Institute level committees and even the various boards such as the Standards Board, the US Activities Board, the Technical Activities Board, and many others. In line with this policy and the underlying philosophy of a periodic outside review, the Region 3 Operations Manual calls for a review of each of the Region 3 standing committees every four years. In 1994 the Conference Committee, the Educational Activities Committee, and the Membership Development Committee will be reviewed. The review criteria specifies that the Review Committee shall delve

into the effectiveness, continued need, policies, procedures, action, composition, budget considerations, and any other aspects of the committee being reviewed as appropriate.

Specifically, for each committee, the objectives, responsibilities, and structure will be examined. Additionally, the review will look at the schedule for completing goals and objectives, and any training sessions/workshops or short courses held. Also included are the committee membership, nominations of Region 3 members for awards, and any special projects. Of course, the committee finances will also be examined. The review committee will be looking at the functioning of each of the committees over the past four years. Past committee chairs should be sure to pass on to their successor all past records, and present chairmen should ask for them.

Many may look at the review process as a criticism of a committee and its operation. It is not that at all, but an opportunity to find ways to improve the operation and provide even greater service to our members. After the review committee makes its report, the reviewed committee has the opportunity to respond, and both reports are submitted to the Director. The only way improvement will be made is for the chairman of the standing committee to incorporate recommendations from the review committee into the committee operation.

EARLY WARNING - The Public Information Committee and the Strategic Planning Committee will be reviewed next year.
